

“Hitachi Refrigerator Bonus Offer” Full Terms & Conditions

Eligibility

1. Information on how to claim the Bonus Product form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. This offer is not valid in conjunction with any other offer.
2. Any costs associated with entering this promotion, are the responsibility of the claimants.
3. Entry is only open to residents of Australia aged 18 years and over currently residing in Australia who: (a) purchase a Participating Product during the Promotional Period from a participating retail outlet and (b) comply with all Bonus requirements. Directors, management and employees (and their immediate families and members of their households) of the Promoter or its related entities, suppliers, providers and agencies whom are directly associated with the conduct of this Promotion and their immediate family and friends are ineligible to enter the promotion.

 - (a) ‘Bonus Product’ means Global IKASU 7-piece Knife Block corresponding with the Purchase of the Participating Products as specified in the table in clause 6.

 - (c) ‘Purchase’ means the purchase of the Participating Products in a single transaction with payment in full during the Promotional Period from participating Stockists of Hitachi Made in Japan refrigerators.
